On January 12, 2010, an application was filed by 3U Telecom Inc. ("3U") of Carson City, Nevada, seeking approval of a name change to Telecom North America Inc., d/b/a Telna Inc. Notice of the application was published in The Daily Record, Omaha, Nebraska, on January 15, 2010. No protests were filed; therefore, we process this application pursuant to the Commission's Rule of Modified Procedure.

O P I N I O N     A N D     F I N D I N G S

3U is a corporation with its principal offices located at 1802 N. Carson Street, Ste. 108-2683, Carson City, Nevada 89701. 3U operates pursuant to a certificate of public convenience and necessity issued by this Commission September 24, 2002, under Docket C-2784 and is subject to the jurisdiction of this Commission.

In the present application, 3U requests that the Commission enter an order approving the adoption by 3U of the name "Telecom North America Inc., d/b/a Telna Inc.". 3U has received authority from the Secretary of State to use the new name. The adoption of the new name will have no effect on the rates, terms or conditions of 3U's provision of telecommunications services to its customers. Based on all the evidence adduced, the Commission is of the opinion the application is in the public interest and should be granted.

O R D E R

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that Application No. C-4242 be, and it is hereby, granted and the request of 3U Telecom Inc. to change its name to Telecom North America Inc., d/b/a Telna Inc. is approved.
