By application filed January 25, 2010, Consolidated Telephone Company (Consolidated) of Lincoln, seeks authority to consolidate certain local exchanges and convert EAS service to local exchange service. Notice of the application was published in The Daily Record, Omaha, Nebraska, on January 28, 2010. No protests were filed; therefore, this application is processed pursuant to the Commission's Rule of Modified Procedure.

Consolidated currently provides local exchange service in the following 15 local exchanges: Anselmo, Arthur, Ashby, Bingham, Brewster, Brownlee, Dunning, Halsey, Hyannis, Merna, Mullen, Purdum, Seneca, Thedford and Whitman. Consolidated proposes to merge its 15 exchanges identified in its application into four exchanges so as to result in the following local exchange areas:

- a. The Hyannis exchange shall be comprised of the previous local exchanges of Hyannis, Arthur, Ashby, Bingham, and Whitman.
- b. The Merna exchange shall be comprised of the previous local exchanges of Merna and Anselmo.
- c. The Mullen local exchange shall remain unchanged.
- d. The Thedford local exchange shall be comprised of the previous local exchanges of Thedford, Brewster, Brownlee, Dunning, Halsey, Purdum and Seneca.

Where EAS service was previously offered that service would now become local exchange service as follows:
