BY THE COMMISSION:

By application filed March 1, 2010, Southeast Nebraska Communications, Inc. (Southeast), Falls City, seeks approval of an Interconnection and Reciprocal Compensation Agreement with Time Warner Cable Information Services (Nebraska), LLC (Time Warner), New York, New York. Notice of the application was published in The Daily Record, Omaha, Nebraska, on March 11, 2010. No protests were filed; therefore, this application is processed pursuant to the Commission's Rule of Modified Procedure.

Pursuant to Section 252(a) of the Telecommunications Act of 1996 (the Act), Southeast and Time Warner (parties) entered into an Interconnection and Reciprocal Compensation Agreement arrived at through voluntary negotiations. An executed copy of this agreement is contained within the application.

No portion of the agreement discriminates against any telecommunications carrier. Furthermore, the implementation of the agreement is consistent with the public interest, convenience and necessity.

Section 252(e) of the Act requires this Commission to review interconnection agreements adopted by negotiation or arbitration to ensure they comply with Sections 251 and 252(d) of the Act, as well as all applicable state laws. Using those standards, the interconnection agreement should be approved.


