## BY THE COMMISSION:

By application filed March 1, 2010, Nebraska Central Telephone Company (Nebraska Central), Gibbon, seeks approval of a Traffic Exchange Agreement with Verizon Wireless (Verizon), Alpharetta, Georgia. Notice of the application was published in <a href="The Daily Record">The Daily Record</a>, Omaha, Nebraska, on March 9, 2010. No protests were filed; therefore, this application is processed pursuant to the Commission's Rule of Modified Procedure.

Pursuant to Section 252(a) of the Telecommunications Act of 1996 (the Act), Nebraska Central and Verizon entered into a Traffic Exchange Agreement arrived at through voluntary negotiations. An executed copy of this agreement is contained within the application.

Neither the agreement nor any portion thereof discriminates against any telecommunications carrier. Furthermore, the implementation of the agreement is consistent with the public interest, convenience and necessity.

Section 252(e) of the Act requires this Commission to review interconnection agreements adopted by negotiation or arbitration to ensure they comply with Sections 251 and 252(d) of the Act, as well as all applicable state laws. Using those standards, the Traffic Exchange Agreement should be approved.

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that the Traffic Exchange Agreement between Nebraska Central Telephone Company and Verizon Wireless, be, and it is hereby, approved.
