BY THE COMMISSION:

By application filed March 17, 2010, Houlton Enterprises, Inc. d/b/a Guaranteed Phone Service, (Houlton) Council Bluffs, Iowa, is seeking authority to withdraw its certificate of authority to provide resold local exchange telecommunications services in the State of Nebraska, previously approved in Docket C-1782. Notice of the application was published in The Daily Record, Omaha, Nebraska, on March 24, 2010. No protests were filed; therefore, this application is processed pursuant to the Commission's Rule of Modified Procedure.

O P I N I O N A N D F I N D I N G S

On August 4, 1998, Houlton was granted authority to operate as a reseller of local exchange telecommunications services within the State of Nebraska pursuant to Docket C-1782.

By application received on March 17, 2010, Houlton requested the withdrawal of its authority to operate as a local exchange carrier of telecommunications services in the State of Nebraska. Houlton notified its few remaining customers pursuant to Nebraska law and no longer provides telecommunications service in Nebraska.

Upon consideration of the request and being fully advised, the Commission finds the request to be reasonable and finds that Houlton's authority to operate as a reseller of local exchange telecommunications services in the State of Nebraska should be cancelled and its tariffs withdrawn.

O R D E R

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that Application No. C-4258 be, and it is hereby, granted and the Certificate of Public Convenience and Necessity to provide local exchange telecommunications services previously granted to Houlton Enterprises, Inc. d/b/a Guaranteed Phone Service, is cancelled.

IT IS FURTHER ORDERED that any Houlton Enterprises, Inc. d/b/a Guaranteed Phone Service tariffs be, and are hereby, withdrawn.
