### OPINION AND FINDINGS

On March 19, 2010, Qwest Corporation ("Qwest") of Denver, Colorado, filed an application seeking approval of a Collocation Miscellaneous Labor Charges Amendment to its Interconnection Agreement with AT&T Communications of the Midwest, Inc. (AT&T), New York, New York. This agreement amends the Interconnection Agreement previously approved in Docket C-3095. Notice of the application was published in The Daily Record, Omaha, Nebraska, on March 26, 2010. No protests were filed; therefore, this application is processed pursuant to the Commission's Rule of Modified Procedure.

On July 27, 2004, in Docket C-3095, the original Interconnection Agreement between Qwest and Tapproved by the Commission. In the current application, Qwest seeks to amend the agreement by adding a Collocation Miscellaneous Labor Charges Amendment the Interconnection Agreement. An executed copy of amendment is contained within the application.

The amendment does not discriminate against any telecommunications carrier. Furthermore, the implementation of the amendment is consistent with the public interest, convenience and necessity.

Section 252(e) of the Act requires this Commission to review negotiated interconnection agreements to ensure they comply with Sections 251 and 252(d) of the Act, as well as all applicable state laws. Using those standards, the Amendment should be approved.
