BY THE COMMISSION:

On April 2, 2010, an application was filed by Global Crossing North American Networks, Inc. (GCNAN), Rochester, New York, seeking approval of a merger with Global Crossing Telecommunications, Inc. (GCTI), Rochester, New York, and cancellation of GCNAN's Certificate of Public Convenience and Necessity. Notice of the application was published in The Daily Record, Omaha, on April 7, 2010. No protests were filed; therefore, this application is processed pursuant to the Commission's Rule of Modified Procedure.

O P I N I O N A N D F I N D I N G S

I. The Parties

GCNAN is a Delaware corporation with its headquarters in Rochester, New York. GCNAN was granted authority to provide interexchange telecommunication services by this Commission on January 31, 1995, in Docket C-1139. GCNAN is a wholly owned indirect subsidiary of Global Crossing Limited (GCL), and does not provide retail telecommunications services.

GCTI is a Michigan corporation with its principal offices in Rochester, New York. GCTI was authorized to provide resale long distance services by this Commission on August 1, 1989, in Docket C-772. GCTI is a wholly owned indirect subsidiary of GCL, and provides resold intrastate toll telecommunications services.

II. The Transaction

GCNAN will merge into GCTI on or about September 30, 2010. All assets of GCNAN will be transferred to GCTI and GCNAN will cease to exist. As a result, GCNAN requests cancellation of its

certificate of public convenience and necessity and tariff upon the date of merger as notified to the Commission.

III. Public Interest

Applicant states that there will be no impact on customers, since Applicant does not provide retail service. Further, Applicant states that the proposed merger will reduce costs and provide enhanced efficiencies for surviving Global Crossing entities. There will be no changes to rates, terms and conditions of service.

Based on the evidence, we find the application to be fair and reasonable and in the public interest. The application should be granted. The Applicants shall notify the Commission as of the date the transaction is finalized and the cancellation of authority of GCNAN shall become effective upon receipt of such notice by the Commission.

O R D E R

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that Application No. C-4266 be, and is hereby, granted.

IT IS FURTHER ORDERED that the Certificate of Public Convenience and Necessity to provide interexchange telecommunications services previously granted to Global Crossing North American Networks, Inc., be, and is hereby, cancelled, upon notice to the Commission as provided herein.
