# BY THE COMMISSION:

On June 22, 2010, an application was filed by TDS Long Distance Corporation (Applicant), Madison, Wisconsin, seeking authority to operate as an interexchange carrier of telecommunications services within the State of Nebraska. Notice of the application was published in <a href="The Daily Record">The Daily Record</a>, Omaha, Nebraska, on June 25, 2010. No protests were filed; therefore, this application is processed pursuant to the Commission's rule of modified procedure.

### OPINION AND FINDINGS

Applicant is a privately held corporation, organized under the laws of the State of Delaware. Applicant has been authorized by the Secretary of State to operate in Nebraska as a foreign corporation. In addition, no officer, director or shareholder having five percent or more of the applicant's voting securities has been involved in a formal complaint or other investigatory or enforcement proceeding.

Applicant is mostly a switchless, non-facilities-based reseller of interexchange telecommunications services provided over the networks of its underlying carrier, Sprint. Initially Applicant proposes to offer only private line service via resale to business customers throughout the State of Nebraska. In the future the Applicant may offer other services provided by other registered interexchange carriers. All network services are supplied by Applicant's underlying carrier. Applicant does not propose to provide alternative operator services nor require advanced payments or deposits.

Interexchange applications are subject to Commission jurisdiction under Neb. Rev. Stat. § 86-129 and Title 291 of the Commission's Rules and Regulations, Chapter 5, Rule 003.12. From examination of the application filed herein, the Commission finds that Applicant has provided all the information required by the Commission, possesses adequate financial resources to

provide the proposed service, and possesses adequate technical competency to provide the proposed service. The application should be granted.

# ORDER

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that Application No. C-4285 be, and it is hereby, granted and TDS Long Distance Corporation, is authorized to operate as an interexchange carrier of telecommunications services within the state of Nebraska.
