## BY THE COMMISSION:

By application filed August 5, 2010, Qwest Corporation (Qwest) of Denver, Colorado, seeks approval of a DC Power Reduction, Restoration and Deactivation Amendment to the Interconnection Agreement with MCImetro Access Transmission Services, LLC (MCImetro), McLean, Virginia, previously granted in Docket C-3703. Notice of the application was published in <a href="The Daily Record">The Daily Record</a>, Omaha, Nebraska, on August 10, 2010. No protests were filed; therefore, this application is processed pursuant to the Commission's Rule of Modified Procedure.
