switchless, non-facilities Applicant is а interexchange resale carrier providing switched and dedicated interexchange telecommunications services to businesses. seeks authority to operate interexchange as an telecommunications carrier in the State of Nebraska, with services provided periodically by other registered interexchange carriers. Applicant proposes to offer billing services and 24hour customer service through a toll free number.

Interexchange applications are subject to Commission jurisdiction under $\underline{\text{Neb. Rev. Stat.}}$ § 86-129 and Title 291 of the Commission's Rules and Regulations, Chapter 5, Rule 003.12. From examination of the application filed herein, the Commission finds that Applicant has provided all the information required by the Commission, possesses adequate financial resources to provide the proposed service, and possesses adequate technical

competency to provide the proposed service. The application should be granted.
