## BY THE COMMISSION:

application filed February 24, 2011, Owest Corporation (Qwest) of Denver, Colorado, seeks approval of amendment to the interconnection agreement with McLeodUSA Telecommunications Services, LLC d/b/a Paetec (Paetec), Iowa, Business Services Hiawatha, previously granted in Docket C-2023. Notice of the application was published in The Daily Record, Omaha, Nebraska, on March 3, 2011. No protests were filed; therefore, this application is processed pursuant to the Commission's Rule of Modified Procedure.

Pursuant to Section 252(a) of the Telecommunications Act of 1996 (the Act), Qwest and Paetec (parties) entered into an interconnection agreement arrived at through voluntary negotiations and previously granted in Docket C-2023.
