BY THE COMMISSION:

On March 3, 2011, an application was filed by Larry Ellis, Kevin Stewart, Les Tweedy and Alvin Satterwhite, all of Emerson, Nebraska, seeking authority for a boundary change to receive telephone service from the Jackson-Hubbard exchange of Northeast Nebraska Telephone Company ("NNTC"), Jackson, Nebraska, in lieu of telephone service from Qwest Communications d/b/a CenturyLink ("CenturyLink"). The Commission forwarded a copy of the application to CenturyLink on March 7, 2011. Notice of the application was published in The Daily Record, Omaha, Nebraska, on March 25, 2011.

On August 16, 2011, CenturyLink filed a letter with the Commission stating that it did not consent to the boundary change application. Changes of a local exchange territory are governed by Neb. Rev. Stat. §§ 86-135 to 86-138. Section 86-135 states that the Commission shall hold a public hearing if all telephone carriers involved do not consent to the application. Because CenturyLink does not consent to the proposed boundary change, the Commission finds that a hearing shall be held on this matter on November 21, 2011 at 1:30 p.m. CDT in the Commission Hearing Room, 300 the Atrium Building, 1200 N Street, Lincoln, Nebraska.
