## BY THE COMMISSION:

## OPINION AND FINDINGS

Liberty-Bell operates pursuant to a certificate of public convenience and necessity issued by this Commission July 27, 2010 under Dockets C-4283 and is subject to the jurisdiction of this Commission.

In the present application, Liberty-Bell requests that the Commission enter an order approving the adoption by Liberty-Bell of the name "Liberty-Bell Telecom, LLC d/b/a DISH Network Phone & Internet". Liberty-Bell has received authority from the Secretary of State to use the new name. The adoption of the new name will have no effect on the rates, terms or conditions of Liberty-Bell's provision of telecommunications services to its customers. Based on the all the evidence adduced, the Commission is of the opinion the application is in the public interest and should be granted.
