BY THE COMMISSION:

On April 18, 2011, an application was filed by Evercom Systems, Inc. ("Evercom") of Dallas, Texas, seeking approval of a name change to Securus Technologies, Inc. Notice of the application was published in The Daily Record, Omaha, Nebraska, on April 21, 2011. No protests were filed; therefore, we process this application pursuant to the Commission's Rule of Modified Procedure.

O P I N I O N A N D F I N D I N G S

Evercom is a Delaware corporation with its principal offices located at 14651 Dallas Parkway, Suite 600, Dallas, Texas, 75254. Evercom operates pursuant to a certificate of public convenience and necessity issued by this Commission January 5, 1999, under Docket C-1944 and is subject to the jurisdiction of this Commission.

In the present application, Evercom requests that the Commission enter an order approving the adoption by Evercom of the name "Securus Technologies, Inc.". Evercom has received authority from the Secretary of State to use the new name. The adoption of the new name will have no effect on the rates, terms or conditions of Evercom's provision of telecommunications services to its customers. Based on all the evidence adduced, the Commission is of the opinion the application is in the public interest and should be granted.

O R D E R

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that Application No. C-4353.1 be, and it is hereby, granted and the request of Evercom Systems, Inc. to change its name to Securus Technologies, Inc. is approved.

IT IS FURTHER ORDERED that the Applicant file an updated tariff reflecting the change in name within 30 days of the date of this order.
