BY THE COMMISSION:

On April 20, 2011, an application was filed by Treasure Lake, L.P. (Applicant), Coudersport, Pennsylvania, seeking authority to operate as an interexchange carrier of telecommunications services within the State of Nebraska. Notice of the application was published in The Daily Record, Omaha, Nebraska, on April 28, 2011. No protests were filed; therefore, this application is processed pursuant to the Commission's rule of modified procedure.

O P I N I O N   A N D   F I N D I N G S

Applicant is a privately held limited partnership organized under the laws of the State of Delaware since December 6, 2005. Applicant has been authorized by the Secretary of State to operate in Nebraska as a foreign corporation. In addition, no officer, director or shareholder having five percent or more of the applicant's voting securities has been involved in a formal complaint or other investigatory or enforcement proceeding.

Applicant seeks authority to operate as an interexchange telecommunications carrier in the State of Nebraska, and proposes to offer switched and dedicated access "1+" long distance telecommunications services suitable for voice and limited data applications between different points within the state. Applicant will provide billing services, and customer service will be available 24 hours a day through a toll free 800 number.

Interexchange applications are subject to Commission jurisdiction under Neb. Rev. Stat. § 86-129 and Title 291 of the Commission's Rules and Regulations, Chapter 5, Rule 003.12. From examination of the application filed herein, the Commission finds that Applicant has provided all the information required by the Commission, possesses adequate financial resources to provide the proposed service, and possesses adequate technical competency to provide the proposed service. The application should be granted.

O R D E R

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that Application No. C-4357 be, and it is hereby, granted and Treasure Lake, L.P. is authorized to operate as an interexchange carrier of telecommunications services within the State of Nebraska.
