BY THE COMMISSION:

On May 23, 2011, a joint application was filed by Qwest Corporation (Qwest), Vancouver, Washington, and Broadvox-CLEC, LLC (Broadvox-CLEC), Cleveland, Ohio, seeking approval of the adoption of an Interconnection Agreement pursuant to 47 U.S.C. §252(i). Notice of the application was published in The Daily Record, Omaha, Nebraska, on June 17, 2011. No protests were filed; therefore, this application is processed pursuant to the Commission's Rule of Modified Procedure.

Section 252(i) of the Telecommunications Act of 1996 allows any telecommunications carrier to adopt a Commission-approved Interconnection Agreement. Broadvox-CLEC wishes to establish an Interconnection Agreement with Qwest and accordingly seeks to adopt the Neutral Tandem, Inc. Interconnection Agreement. The Agreement was approved by the Commission pursuant to Docket C-4278 on July 13, 2010.

On May 28, 1997, the Commission added language to its mediation/arbitration policy (see Docket C-1128, Progression Order No. 3) which sets forth the procedures to be followed for a Section 252(i) request. Qwest and Broadvox-CLEC have sufficiently complied with the procedures required by the Commission's policy.

O R D E R

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that Application No. C-4369 be, and it is hereby, approved and Qwest Corporation and Broadvox-CLEC, LLC are hereby authorized to adopt the voluntarily negotiated Interconnection Agreement between Qwest Corporation and Neutral Tandem, Inc.
