## BY THE COMMISSION:

On June 16, 2011, an application was filed by U.S. Telecom Long Distance, Inc. ("U.S. Telecom"), Las Vegas, Nevada, seeking approval of a transfer of certain long distance business customers from Consumer Telcom, Inc. ("Consumer Telcom"), Henderson, Nevada, to U.S. Telecom. Notice of the application was published in <a href="The Daily Record">The Daily Record</a>, Omaha, Nebraska, on August 16, 2011. No protests were filed; therefore, this application is processed pursuant to the Commission's Rule of Modified Procedure.

## OPINION AND FINDINGS

#### The Parties:

U.S. Telecom is a Nevada corporation with principal offices located in Las Vegas, Nevada. U.S. Telecom was authorized as an interexchange telecommunications services provider in the State of Nebraska by virtue of authority granted by the Commission on January 27, 1998, under Docket C-1711.

Consumer Telcom is a Nevada corporation with principal offices in Henderson, Nevada. Consumer Telcom was authorized as an interexchange telecommunications services provider in the State of Nebraska by virtue of authority granted by the Commission on August 14, 2007, under Docket C-3823.

# Description of the Transaction:

According to the application, U.S. Telecom will acquire certain long distance business customers of Consumer Telcom due to Consumer Telcom scaling back on select business operations.

The Applicants anticipate that the proposed transaction will be transparent to any customers in Nebraska. The Applicants state that the proposed transaction is in the public

interest because there will be no change in rates, service, or terms and conditions.

Based on the evidence, we find the application to be fair and reasonable and in the public interest. The application should be granted.

ORDER

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that Application No. C-4370, be, and it is hereby, granted.
