By application filed June 17, 2011, Qwest Corporation (Qwest), Denver, Colorado, seeks approval of an amendment to the Interconnection Agreement with XO Communications Services, Inc. (XO), Salt Lake City, Utah, previously granted in Docket C-3939. Notice of the application was published in The Daily Record, Omaha, Nebraska, on June 23, 2011. No protests were filed; therefore, this application is processed pursuant to the Commission's Rule of Modified Procedure.
