By application filed June 21, 2011, Alltel Communications, Inc. (Alltel), Alpharetta, Georgia, seeks approval of an amendment to the Wireless Interconnection and Reciprocal Compensation Agreement with Northeast Nebraska Telephone Company (NNTC), Jackson, Nebraska, previously granted in Docket C-3178. Notice of the application was published in The Daily Record, Omaha, Nebraska, on June 27, 2011. No protests were filed; therefore, this application is processed pursuant to the Commission's Rule of Modified Procedure.
