By application filed June 21, 2011, Alltel Communications, Inc. (Alltel), Alpharetta, Georgia, seeks approval of an amendment to the Wireless Interconnection and Reciprocal Compensation Agreement with Rock County Telephone Company (Rock), Blair, Nebraska, previously granted in Docket C-3199.
