By application filed June 21, 2011, Alltel Communications, Inc. (Alltel), Alpharetta, Georgia, seeks approval of an amendment to the Wireless Interconnection and Reciprocal Compensation Agreement with Clarks Telecommunications Company (Clarks), Jackson, Nebraska, previously granted in Docket C-3165. Notice of the application was published in The Daily Record, Omaha, Nebraska, on June 27, 2011. No protests were filed; therefore, this application is processed pursuant to the Commission's Rule of Modified Procedure.

Pursuant to Section 252(a) of the Telecommunications Act of 1996 (the Act), Alltel and Clarks (parties) entered into a Wireless Interconnection and Reciprocal Compensation Agreement arrived at through voluntary negotiations and previously granted in Docket C-3165. Interconnection and Reciprocal Compensation Agreement should be approved.
