By application filed June 21, 2011, Alltel Communications, Inc. (Alltel), Alpharetta, Georgia, seeks approval of an amendment to the Wireless Interconnection and Reciprocal Compensation Agreement with Hartington Telecommunications Company (Hartington), Hartington, Nebraska, previously granted in Docket C-3166.
