By application filed June 22, 2011, Alltel Communications, Inc. (Alltel), Alpharetta, Georgia, seeks approval of an Wireless Interconnection and Reciprocal Compensation Agreement with Consolidated Telephone Company (Consolidated), Lincoln, Nebraska, previously granted in Docket C-3193. Notice of the application was published in The Daily Record, Omaha, Nebraska, on June 28, 2011. No protests were filed; therefore, this application is processed pursuant to the Commission's Rule of Modified Procedure.
