BY THE COMMISSION:

On May 16, 2011, an application was filed by Tim Erickson of Phelps County, Nebraska, seeking authority for a boundary change to receive telephone service from the adjacent exchange of Glenwood Telephone Company, ("Glenwood") in lieu of his current telephone service from CenturyLink QC f/k/a Qwest Corporation ("CenturyLink"). Notice of the application was published in The Daily Record, Omaha, Nebraska, on June 28, 2011.

O P I N I O N A N D F I N D I N G S

Glenwood and CenturyLink are local exchange carriers holding certificates of public convenience and necessity to provide local exchange service in their respective territories. Tim Erickson resides within the boundaries of CenturyLink's exchange, and has requested a boundary change so that he may receive local exchange service from the Glenwood exchange. CenturyLink has notified the Commission that it does not oppose the proposed boundary change. An exchange map showing the CenturyLink and Glenwood exchanges was provided to the Commission along with a legal description of the location at which service is requested from Glenwood.

Changes of a local exchange territory are governed by *Neb. Rev. Stat.* §§ 86-135 to 86-138. Section 86-135 states that only upon non-consent of all telephone carriers involved shall the Commission hold a public hearing in the application. With no protest filed by any party and with each of the affected local exchange carriers consenting to the boundary change, the Commission processes this application administratively and without a public hearing.

The Commission finds that, in light of the agreement between all parties involved, the application is in the public interest and should be granted.

O R D E R

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that Application No. C-4388 be, and it is hereby, granted.

IT IS FURTHER ORDERED that Glenwood Telephone Company and CenturyLink QC f/k/a Qwest Corporation submit revised boundary maps to the Commission within 30 days from the date of this order.
