By application filed June 27, 2011, Alltel Communications, Inc. (Alltel), Alpharetta, Georgia, seeks approval of an amendment to the wireless interconnection and reciprocal compensation agreement with Cambridge Telephone Company (Cambridge), Cambridge, Nebraska, previously granted in Docket C-3271. Notice of the application was published in The Daily Record, Omaha, Nebraska, on June 30, 2011. No protests were filed; therefore, this application is processed pursuant to the Commission's Rule of Modified Procedure.

Pursuant to Section 252(a) of the Telecommunications Act of 1996 (the Act), Alltel and Cambridge (parties) entered into a wireless interconnection and reciprocal compensation agreement arrived at through voluntary negotiations and previously granted in Docket C-3271. Using those standards, the amendment to the wireless interconnection and reciprocal compensation agreement should be approved.
