By application filed August 23, 2011, Qwest Corporation (Qwest), of Denver, Colorado, seeks approval of a Collocation Amendment to the Interconnection Agreement with Pinpoint Communications, Inc. (Pinpoint) of Cambridge, Nebraska. The underlying Interconnection Agreement was approved by the Commission in Docket C-2605.
