BY THE COMMISSION:

On August 25, 2011, an application was filed by New Edge Network, Inc. ("New Edge") of Vancouver, Washington, seeking approval to change its trade name from New Edge Networks to EarthLink Business II. Notice of the application was published in The Daily Record, Omaha, Nebraska, on August 30, 2011. No protests were filed; therefore, we process this application pursuant to the Commission's Rule of Modified Procedure.

OPINION AND FINDINGS

New Edge is a Delaware corporation and an local exchange and interexchange provider of telecommunications in Nebraska.

New Edge was authorized to operate as a local exchange and interexchange carrier of telecommunications services within the State of Nebraska by the Commission pursuant to Dockets C-2127 and C-2128 on November 30, 1999 and December 21, 1999 respectively. In the current application, New Edge wishes to change its trade name from New Edge Networks to EarthLink Business II. New Edge filed the necessary paperwork to change its trade name with the Secretary of State of Nebraska.

The Commission finds New Edge's application should be granted and New Edge shall file a tariff reflecting the new trade name.

ORDER

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that Application No. C-4407 be, and it is hereby, granted and New Edge Network, Inc., is authorized to change its trade name from New Edge Networks to EarthLink Business II.

IT IS FURTHER ORDERED that an updated tariff reflecting the change in name be filed with the Commission accordingly.
