OPINION AND FINDINGS

On September 12, 2011, Qwest Corporation ("Qwest") of Denver, Colorado, filed an application seeking approval of a Single Point of Presence (SPOP) in the LATA Amendment to Interconnection Agreement with Broadvox-CLEC, ("Broadvox"), of Cleveland, Ohio. This agreement amends the Interconnection Agreement previously approved Application No. C-4369. Notice of the application was The Daily Record, Omaha, published in Nebraska, September 15, 2011. No protests were filed; therefore, this application is processed pursuant to the Commission's Rule of Modified Procedure.

On July 26, 2011, in Docket C-4369, the original interconnection agreement between Qwest and Broadvox was approved by the Commission. In the current application, Qwest seeks to amend the agreement by adding a Single Point Presence (SPOP) in the LATA Amendment the Interconnection Agreement. An executed сору of the amendment is contained within the application.

The amendment does not discriminate against any telecommunications carrier. Furthermore, the implementation of the amendment is consistent with the public interest, convenience and necessity.

Section 252(e) of the Act requires this Commission to review negotiated interconnection agreements to ensure they comply with Sections 251 and 252(d) of the Act, as well as all applicable state laws. Using those standards, the Amendment should be approved.
