BY THE COMMISSION:

On September 23, 2011, an application was filed by Cox Nebraska Telcom, LLC, ("Cox" or "Applicant") of Omaha, Nebraska, seeking approval of a corporate change by its parental entity, transferring control of Cox from CoxCom, Inc. to CoxCom, LLC, and a corresponding name change of the parental entity from CoxCom, Inc. to CoxCom, LLC. Notice of the application was published in The Daily Record, Omaha, Nebraska, on September 29, 2011. No protests were filed; therefore, this application is processed pursuant to the Commission's Rule of Modified Procedure.

O P I N I O N A N D F I N D I N G S

The Parties:

Cox is a wholly-owned subsidiary of CoxCom, Inc. Cox is a Delaware corporation headquartered in Omaha, Nebraska. Cox is a competitive local exchange and interexchange carrier providing service in the State of Nebraska under and by virtue of authority heretofore granted by this Commission¹.

Description of the Restructuring:

CoxCom, Inc. undertook a corporate change whereby the control of Cox will be moved from CoxCom, Inc. to CoxCom, LLC. Corresponding with the change, CoxCom, Inc. also changed its name to CoxCom, LLC.

The Applicant states the shareholders and directors of Cox will remain the same after the transfer of control and the technical, financial and managerial fitness of Cox will also remain the same.

The Applicant submits there will be no adverse impact on the public interest and Cox will continue to offer the same high level of telecommunication services it presently provides to its customers. Cox has registered and received approval from the Nebraska Secretary of State to change its parent name to CoxCom, LLC.

Based on the evidence, we find the application to be fair and reasonable and in the public interest. The application should be granted.

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that Application No. C-4411 be, and it is hereby, approved.

IT IS FURTHER ORDERED that CoxCom, Inc. is authorized to change its name to CoxCom, LLC.

IT IS FURTHER ORDERED that if an updated tariff reflecting the change in name of the parent entity of Cox Nebraska Telcom, LLC is necessary it be filed with the Commission accordingly.

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that Application No. C-4411 be, and it is hereby, approved.




IT IS FURTHER ORDERED that CoxCom, Inc. is authorized to change its name to CoxCom, LLC.
