facilities-based and reseller Applicant is а of interexchange telecommunications services provided combination of the Applicant's own facilities, facilities leased from other carriers, and resale of facilities and equipment of other licensed carriers operating in Nebraska. Applicant proposes to offer competitive access services, high-capacity telecommunications services, and long-distance services for enterprise customers and carriers and other network providers. The Applicant also provides Internet and other enhanced services to its customers.

Interexchange applications are subject to Commission jurisdiction under Neb. Rev. Stat. § 86-129 and Title 291 of the Commission's Rules and Regulations, Chapter 5, Rule 003.12. From examination of the application filed herein, the Commission finds that Applicant has provided all the information required by the Commission, possesses adequate financial resources to provide the proposed service, and possesses adequate technical

competency to provide the proposed service. The application should be granted.
