BY THE COMMISSION:

On October 24, 2011 an application was filed by XO Communications Services, Inc. ("XOCS") of Midvale, Utah, seeking approval to change its name to XO Communications Services, LLC. Notice of the application was published in The Daily Record, Omaha, Nebraska, on October 27, 2011. No protests were filed; therefore, we process this application pursuant to the Commission's Rule of Modified Procedure.

O P I N I O N A N D F I N D I N G S

XOCS is a Delaware corporation, which operates as a competitive telecommunications carrier in Nebraska. XOCS is authorized to provide telecommunications services in Nebraska pursuant to the authority granted by this Commission on September 8, 2004, in Docket C-3245.

In the present application, XOCS states that has changed its corporate form from a Delaware corporation to a Delaware limited liability company. Therefore, XOCS requests the Commission enter an order approving the name change to "XO Communications Services, LLC." The converted entity has been registered with the Nebraska Secretary of State as a foreign limited liability company. The adoption of the new name will have no affect on rates, terms, or conditions of service offered to Nebraska customers. This transparency notwithstanding, the applicant has sent notice of the name change to their customers via bill messages.

Based on the all the evidence adduced, the Commission is of the opinion the application is in the public interest and should be granted.

O R D E R

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that Application No. C-4420 be, and it is hereby, granted and the request of XO Communications Services, Inc. to change its name to XO Communications Services, LLC is approved.

IT IS FURTHER ORDERED that the Applicant file its updated tariff reflecting the change in name within 30 days of the date of this order.
