BY THE COMMISSION:

On October 24, 2011 an application was filed by Nextlink Wireless, Inc. ("Nextlink"), of Herndon, Virginia, seeking approval to change its name to Nextlink Wireless, LLC. Notice of the application was published in The Daily Record, Omaha, Nebraska, on October 27, 2011. No protests were filed; therefore, we process this application pursuant to the Commission's Rule of Modified Procedure.

OPINION AND FINDINGS

Nextlink is a Delaware corporation, which operates as a competitive telecommunications carrier in Nebraska. Nextlink is authorized to provide telecommunications services in Nebraska pursuant to the authority granted by this Commission on April 4, 2006, in Docket C-3551.

In the present application, Nextlink states that on August 30, 2011, it converted its corporate form from a Delaware corporation to a Delaware limited liability company. Therefore, Nextlink requests that the Commission enter an order approving the name change to "Nextlink Wireless, LLC." The converted entity has been registered with the Nebraska Secretary of State as a foreign limited liability company. The adoption of the new name will have no affect on rates, terms or conditions of service offered to Nebraska customers. This transparency notwithstanding, the applicant has sent notice of the name change to their customers via bill messages.

Based on the all the evidence adduced, the Commission is of the opinion the application is in the public interest and should be granted.
