#### BY THE COMMISSION:

By application filed October 26, 2011, Dark Fiber Solutions, Inc. (DFS) Hopkinsville, Kentucky, is seeking authority to withdraw its certificate of authority to provide interexchange telecommunications services in the state of Nebraska, previously approved in Docket C-2711. Notice of the application was published in <a href="The Daily Record">The Daily Record</a>, Omaha, Nebraska, on October 31, 2011. No protests were filed; therefore, this application is processed pursuant to the Commission's Rule of Modified Procedure.

#### OPINION AND FINDINGS

On May 14, 2002, DFS was granted authority to provide interexchange telecommunications services within the State of Nebraska pursuant to Docket C-2711.

By application received on October 26, 2011, DFS requested the withdrawal of its authority to operate as an interexchange carrier of telecommunications services in the State of Nebraska. DFS was purchased by Treasure Lake and is no longer providing or billing customers for interexchange services.<sup>1</sup>

Upon consideration of the request and being fully advised, the Commission finds the request to be reasonable and finds that DFS's authority to provide interexchange telecommunications services in the State of Nebraska should be cancelled and its tariffs withdrawn.

## ORDER

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that Application No. C-4422 be, and it is hereby, granted and the Certificate of Public Convenience and Necessity to provide interexchange telecommunications services previously granted to Dark Fiber Solutions, Inc., is withdrawn.

IT IS FURTHER ORDERED that the interexchange tariff of Dark Fiber Solutions, Inc., be, and is hereby, withdrawn.
