### BY THE COMMISSION:

By application filed December 15, 2011, Northstar Telecom, Inc. (NST), Purchase, New York, is seeking authority to withdraw its certificate of authority to provide local exchange and interexchange telecommunications services in the State of Nebraska, previously approved in Docket C-3261. Notice of the application was published in <a href="The Daily Record">The Daily Record</a>, Omaha, Nebraska, on December 20, 2011. No protests were filed; therefore, this application is processed pursuant to the Commission's Rule of Modified Procedure.

## OPINION AND FINDINGS

On November 23, 2004, NST was granted authority to provide local exchange and interexchange telecommunications services within the state of Nebraska pursuant to Docket C-3261.

By application received on December 15, 2011, NST requested the withdrawal of its authority to operate as a local exchange and interexchange carrier of telecommunications services in the State of Nebraska. NST was purchased by Birch Communications Corp. and is no longer providing or billing customers for local exchange or interexchange services.<sup>1</sup>

Upon consideration of the request and being fully advised, the Commission finds the request to be reasonable and finds that DFS's authority to provide local exchange and interexchange telecommunications services in the State of Nebraska should be cancelled and its tariffs withdrawn.

## ORDER

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that Application No. C-4433 be, and it is hereby, granted and the Certificate of Public Convenience and Necessity to provide local exchange and interexchange telecommunications services previously granted to Northstar Telecom, Inc., is withdrawn.
