BY THE COMMISSION:

By application filed February 9, 2012, Zoom-i-Net Communications, Inc. (Zoom-i-Net), Central Square, New York, is seeking authority to withdraw its certificate of authority to operate as a resale interexchange carrier of telecommunications services within the State of Nebraska, previously approved in Docket C-3158. Notice of the application was published in The Daily Record, Omaha, Nebraska, on February 13, 2012. No protests were filed; therefore, this application is processed pursuant to the Commission's Rule of Modified Procedure.

O P I N I O N A N D F I N D I N G S

On April 27, 2004, Zoom-i-Net was granted authority to operate as a resale interexchange carrier of telecommunications services within the state of Nebraska pursuant to Docket C-3158.

By application received on February 9, 2012, Zoom-i-Net requested the withdrawal of its authority to operate as a resale interexchange carrier of telecommunications services in the State of Nebraska. Zoom-i-Net currently does not have any customers in the State of Nebraska.

Upon consideration of the request and being fully advised, the Commission finds the request to be reasonable and finds that Zoom-i-Net's authority to provide resold interexchange telecommunications services in the State of Nebraska should be cancelled and its tariffs withdrawn.

O R D E R

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that Application No. C-4446 be, and it is hereby, granted and the Certificate of Public Convenience and Necessity to provide resold interexchange telecommunications services previously granted to Zoom-i-Net Communications, Inc., is withdrawn.

IT IS FURTHER ORDERED that any interexchange tariff of Zoom-i-Net Communications, Inc., be, and it is hereby, withdrawn.
