BY THE COMMISSION:

By application filed February 21, 2012, Qwest Corporation d/b/a CenturyLink QC (Qwest) of Denver, Colorado, seeks approval of its wireline SGAT Interconnection Agreement with Spectrotel, Inc. (Spectrotel) of Neptune, New Jersey. Notice of the application was published in The Daily Record, Omaha, Nebraska, on February 24, 2012. No protests were filed; therefore, this application is processed pursuant to the Commission's Rule of Modified Procedure.

Pursuant to Section 252(a) of the Telecommunications Act of 1996 (the Act), Qwest and Spectrotel entered into a wireline SGAT Interconnection Agreement arrived at through voluntary negotiations. An executed copy of the SGAT agreement is contained within the application.

Neither the agreement nor any portion thereof discriminates against any telecommunications carrier. Furthermore, the implementation of the agreement is consistent with the public interest, convenience, and necessity.

Section 252(e) of the Act requires this Commission to review interconnection agreements adopted by negotiation or arbitration to ensure they comply with Sections 251 and 252(d) of the Act, as well as all applicable state laws. Using those standards, the SGAT Interconnection Agreement should be approved.

O R D E R

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that the wireline SGAT Interconnection Agreement between Qwest Corporation d/b/a CenturyLink QC, Denver, Colorado, and Spectrotel, Inc., Neptune, New Jersey, be, and it is hereby, approved.
