BY THE HEARING OFFICER:

On February 22, 2012, Pinpoint Wireless, Inc. d/b/a Blaze Wireless ("Pinpoint") filed an application seeking designation as a wireless Eligible Telecommunications Carrier ("ETC") in the State of Nebraska. Notice of the docket was published in The Daily Record, Omaha, Nebraska, on February 27, 2012.

On April 3, 2012, a Petition for Formal Intervention timely filed by N.E. Colorado Cellular, Inc., d/b/a Viaero Wireless ("Viaero") was granted by the Hearing Officer.

Planning Conference

A planning conference was held in the above-captioned docket on April 12, 2012, at 2:30 p.m. in the Commission Niobrara Conference Room, 300 The Atrium, 1200 N Street, Lincoln, Nebraska, and via telephone conference with a representative of Pinpoint. The following persons were present at the conference: for Viaero, Loel P. Brooks of Brooks, Pansing Brooks, PC, LLO and counsel for Viaero, Andrew Newell; for the Commission, Commissioner Jerry Vap, Nichole Mulcahy, Legal Counsel, Gene Hand, Director of the Communications Department, and Sue Vanicek, Director of the Nebraska Telecommunications Infrastructure and Public Safety Department. Participating via telephone for Pinpoint, Russell A. Westerhold of Fraser Stryker PC LLO.

As a result of the planning conference, several issues were decided. Therefore, this order serves to memorialize those decisions and to provide a timeline for proceeding in this docket.


