BY THE HEARING OFFICER:

On February 22, 2012, Pinpoint Wireless, Inc. d/b/a Blaze Wireless ("Pinpoint" or "Applicant") filed an application seeking designation as a wireless Eligible Telecommunications Carrier ("ETC") in the State of Nebraska. Notice of the docket was published in The Daily Record, Omaha, Nebraska, on February 27, 2012.

On April 3, 2012, a Petition for Formal Intervention timely filed by N.E. Colorado Cellular, Inc., d/b/a Viaero Wireless ("Viaero") was granted by the Hearing Officer.

A planning conference was held on April 12, 2012, and a subsequent Hearing Officer Order issued on April 13, 2012, set a procedural schedule and scheduled a hearing on July 11, 2012.

On May 30, 2012, Viaero filed a Motion to Withdraw its Formal Intervention in the above-captioned matter, stating its interests will not be served by continued participation in the docket.

As Viaero was the only Formal Intervener in this matter, I find that the filing deadlines contained in the procedural schedule previously approved are no longer necessary. Further, as the procedural schedule will require less time, I find the hearing in this matter should be rescheduled for an earlier date.

Therefore, being fully advised in the premises, I find that Viaero's Motion to Withdraw its Formal Intervention should be granted, the procedural schedule previously adopted in the above-captioned proceeding modified to remove all pending items except the hearing, and the hearing previously scheduled for July 11, 2012 be rescheduled for **Tuesday, June 19, 2011, at 11:00 a.m.** in the Commission Hearing Room, 300 The Atrium, 1200 N Street, Lincoln, Nebraska.

The Applicant has agreed to arrange for a court reporter for the hearing on this matter. Therefore, the hearing fee of one hundred twenty-five dollars (\$125.00) for each half-day shall be waived consistent with Commission policy.


