BY THE COMMISSION:

On February 27, 2012, an application was filed by ALEC, Inc. ("ALEC"), of Greensboro, Georgia, seeking approval to change its name to ALEC, LLC. Notice of the application was published in The Daily Record, Omaha, Nebraska, on March 2, 2012. No protests were filed; therefore, this application is processed pursuant to the Commission's Rule of Modified Procedure.

O P I N I O N A N D F I N D I N G S

ALEC is a privately held Kentucky corporation and a wholly-owned subsidiary of SinglePipe Communications, Inc. ALEC is authorized to provide local exchange and interexchange telecommunications services in Nebraska pursuant to the authority granted by this Commission on December 16, 2008, in Docket C-3967.

ALEC requests that the Commission enter an order approving the name change to "ALEC, LLC." The converted entity has been registered with the Nebraska Secretary of State as a foreign limited liability company. The adoption of the new name will have no affect on rates, terms, or conditions of service offered to Nebraska customers. ALEC does not currently provide service to any customers within the State of Nebraska.

Based on all the evidence adduced, the Commission is of the opinion the application is in the public interest and should be granted.

ORDER

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that Application No. C-4449 be, and it is hereby, granted and the request of ALEC, Inc. to change its name to ALEC, LLC, is approved.

IT IS FURTHER ORDERED that ALEC file its updated tariff reflecting the change in name within thirty (30) days of the date of this order.
