On March 2, 2012, Hartman Telephone Exchanges, Inc. ("Hartman") Benkelman, Nebraska, gave written notice to the Nebraska Public Service Commission ("Commission") and its customers of its intent to increase its rates for basic local telephone service pursuant to the Nebraska Telecommunications Regulation Act¹ ("The Act").
