## BY THE COMMISSION:

On March 30, 2012, an application was filed by Qwest Corporation d/b/a CenturyLink QC, (CenturyLink) of Denver, Colorado, seeking approval of an Omaha Forbearance Order Amendment to the Interconnection Agreement with Spectrotel, Inc. (Spectrotel) of Neptune, New Jersey, (collectively, the "Parties"). Notice of the application was published in The Daily Record, Omaha, Nebraska, on April 4, 2012. No protests were filed; therefore, this application is processed pursuant to the Commission's Rule of Modified Procedure.

## OPINION AND FINDINGS

Pursuant to Section 252(a) of the Telecommunications Act of 1996 (the Act), the Parties entered into a wireline SGAT Interconnection Agreement (Agreement) for service in the State of Nebraska that was approved by the Nebraska Public Service Commission on April 10, 2012. $^{\rm 1}$ 

On February 28, 2012, the Parties agreed to an Omaha Forbearance Order Amendment (Amendment) to the Interconnection Agreement. The Amendment is intended to amend the Agreement by changing or adding terms and conditions for certain unbundled network elements (UNEs). This Amendment, upon approval by the Commission, will become a part of the Agreement.

Interexchange applications are subject to Commission jurisdiction under Neb. Rev. Stat. § 86-129 and Title 291 of the Commission's Rules and Regulations, Chapter 5, Rule 003.12. Upon full consideration of the facts and circumstances, the Commission finds the Parties have provided all the information required by the Commission, that the Amendment does not
