BY THE COMMISSION:

By application filed April 30, 2012, Sage Telecom, Inc. (Sage), Richardson, Texas, is seeking authority to withdraw its certificate of authority to provide local exchange and interexchange telecommunications services in the State of Nebraska, previously approved in Docket C-3859. Notice of the application was published in The Daily Record, Omaha, Nebraska, on May 4, 2012. No protests were filed; therefore, this application is processed pursuant to the Commission's Rule of Modified Procedure.

O P I N I O N A N D F I N D I N G S

On December 11, 2007, Sage was granted authority to provide resold and facilities-based local exchange and interexchange telecommunications services within the State of Nebraska pursuant to Docket C-3859.

By application received on April 30, 2012, Sage requested the withdrawal of its authority to operate as an exchange and interexchange carrier of telecommunications services in the State of Nebraska. Sage was purchased by TSC Acquisition Corp. and is no longer providing or billing customers for local exchange or interexchange services in the state of Nebraska.

Upon consideration of the request and being fully advised, the Commission finds the request to be reasonable and finds that Sage's authority to provide local exchange and interexchange telecommunications services in the State of Nebraska should be cancelled and its tariffs withdrawn.

O R D E R

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that Application No. C-4466 be, and it is hereby, granted and the Certificate of Public Convenience and Necessity to provide local exchange and interexchange telecommunications services previously granted to Sage Telecom, Inc., is withdrawn.

IT IS FURTHER ORDERED that any local exchange or interexchange tariff of Sage Telecom, Inc., be, and it is hereby, withdrawn.
