BY THE COMMISSION:

On May 2, 2012, an application was filed by Liberty-Bell Telecom, LLC d/b/a DISH Network Phone & Internet ("DISH"), of Englewood, Colorado, seeking approval to change its name to dishNET Wireline, LLC. Notice of the application was published in The Daily Record, Omaha, Nebraska, on May 7, 2012. No protests were filed; therefore, this application is processed pursuant to the Commission's Rule of Modified Procedure.

## O P I N I O N      A N D      F I N D I N G S

DISH is a limited liability company headquartered in Englewood, Colorado. DISH is authorized to provide local exchange, interexchange, and access telecommunications services in Nebraska pursuant to the authority granted by this Commission on July 27, 2010, in Docket C-4283.

DISH requests that the Commission enter an order approving the name change to "dishNET Wireline L.L.C." The converted entity has been registered with the Nebraska Secretary of State as a foreign limited liability company. There has been no internal reorganization or change in the control of DISH and there will be no change in its operations. The adoption of the new name will have no affect on rates, terms, or conditions of service offered to Nebraska customers. DISH will provide notice of the name change to all affected customers.

Based on all the evidence adduced, the Commission is of the opinion the application is in the public interest and should be granted.

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that Application No. C-4468 be, and it is hereby, granted and the request of Liberty-Bell Telecom, L.L.C. d/b/a DISH Network Phone & Internet to change its name to dishNET Wireline, L.L.C., is approved.
