BY THE COMMISSION:

By application filed May 10, 2012, Yak Communications (America), Inc. (Yak), Miami Beach, Florida, is seeking authority to withdraw its certificate of authority to operate as a resale interexchange carrier of telecommunications services within the State of Nebraska, previously approved in Docket C-2963. Notice of the application was published in The Daily Record, Omaha, Nebraska, on May 16, 2012. No protests were filed; therefore, this application is processed pursuant to the Commission's Rule of Modified Procedure.

OPINION AND FINDINGS

On July 15, 2003, Yak was granted authority to operate as a resale interexchange carrier of telecommunications services within the State of Nebraska pursuant to Docket C-2963.

By application received on May 10, 2012, Yak requested the withdrawal of its authority to operate as a resale interexchange carrier of telecommunications services in the State of Nebraska. Yak currently does not have any customers in the State of Nebraska.

Upon consideration of the request and being fully advised, the Commission finds the request to be reasonable and finds that Yak's authority to provide resold interexchange telecommunications services in the State of Nebraska should be cancelled and its tariffs withdrawn.

ORDER

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that Application No. C-4472 be, and it is hereby, granted and the Certificate of Public Convenience and Necessity to provide resold interexchange telecommunications services previously granted to Yak Communications (America), Inc., is withdrawn.

IT IS FURTHER ORDERED that any interexchange tariff of Yak Communications (America), Inc., be, and it is hereby, withdrawn.
