BY THE COMMISSION:

On July 20, 2012, an application was filed by Qwest Corporation d/b/a CenturyLink QC (CenturyLink) of Denver, Colorado, seeking termination of the Wholesale Service Order Charge Amendment to the Interconnection Agreement with McLeodUSA Telecommunications Services, Inc. d/b/a PAETEC Business Services d/b/a Windstream Communications (Windstream) of Little Rock, Arkansas (collectively, the "Parties"). Notice of the application was published in The Daily Record, Omaha, Nebraska, on July 26, 2012. No protests were filed; therefore, this application is processed pursuant to the Commission's Rule of Modified Procedure.

OPINION AND FINDINGS

Pursuant to Section 252(a) of the Telecommunications Act of 1996 (the Act), the Parties entered into an Interconnection Agreement (Agreement) for service in the State of Nebraska that was approved by the Nebraska Public Service Commission on April 14, 1999. Thereafter, the Parties entered into a Wholesale Service Order Charge Amendment (WSOC Amendment) to the Interconnection Agreement that was approved by the Commission on March 10, 2009.
