## BY THE COMMISSION:

## OPINION AND FINDINGS

Applicant is a privately-held Florida corporation with its principal place of business at 1658 Gates Boulevard, Suite B, San Diego, CA 92154. Applicant is authorized to provide resold interexchange telecommunications services in Nebraska pursuant to the authority granted by this Commission on February 14, 2012, in Docket C-4435.

In the present application, the Applicant requests that the Commission enter an order approving the adoption by Applicant of the name "Simple Billing Solutions." Applicant has received authority from the Secretary of State to use the new name. The adoption of the new name will have no effect on the rates, terms, or conditions of Applicant's provision of telecommunications services to its customers.

Based on all the evidence adduced, the Commission is of the opinion the application is in the public interest and should be granted.
