### BY THE COMMISSION:

On September 12, 2012, an application was filed by Qwest Corporation d/b/a CenturyLink QC (CenturyLink) of Denver, Colorado, seeking approval of an ICC VoIP Amendment to the Interconnection Agreement with Broadvox-CLEC, LLC (Broadvox) of Cleveland, Ohio (collectively, the "Parties"). Notice of the application was published in <a href="The Daily Record">The Daily Record</a>, Omaha, Nebraska, on September 14, 2012. No protests were filed; therefore, this application is processed pursuant to the Commission's Rule of Modified Procedure.

# OPINION AND FINDINGS

Pursuant to Section 252(a) of the Telecommunications Act of 1996 (the Act), the Parties entered into an Interconnection Agreement (Agreement) for service in the State of Nebraska that was approved by the Nebraska Public Service Commission on July 26, 2011.

On August 28, 2012, the Parties agreed to an ICC VoIP Amendment (Amendment) to the Interconnection Agreement. The Amendment is intended to amend the Agreement by adding the terms, conditions, and rates contained therein. This Amendment, upon approval by the Commission, will become a part of the Agreement.

Section 252(e) of the Act requires this Commission to review negotiated interconnection agreements to ensure they comply with Sections 251 and 252(d) of the Act, as well as all applicable state laws. Using those standards, the Amendment should be approved.
