## BY THE COMMISSION:

On September 20, 2012, an application was filed by Shane Van Pelt, of Hordville, Nebraska, seeking a boundary change to receive telephone service from the adjacent Hamilton Telecommunications Hordville exchange in lieu of his current telephone service from Windstream Communications, Inc. ("Windstream"). Notice of the application was published in The Daily Record, Omaha, Nebraska, on September 26, 2012.

#### OPINION AND FINDINGS

Hamilton Telecommunications ("Hamilton") and Windstream are local exchange carriers holding certificates of public convenience and necessity to provide local exchange service in their respective territories. Shane Van Pelt resides within the boundaries of Windstream's Polk Exchange and has requested a boundary change so that he may receive local exchange service from the Hordville Exchange. Windstream has notified the Commission that it does not oppose the proposed boundary change.

Changes of a local exchange territory are governed by Neb. Rev. Stat. §§ 86-135 to 86-138. Section 86-135 states that only upon non-consent of all telephone carriers involved shall the Commission hold a public hearing in the application. protest filed by any party and with each of the affected local exchange carriers consenting to the boundary change, this application administratively Commission processes and a public hearing. Hamilton, Windstream, Commission staff have collaborated and modified the relevant exchange maps to show the agreed upon boundary changes portions of the Polk and Hordville Exchanges. A copy of the two exchange maps with the agreed upon revisions is attached as Appendix "A" to this Order and hereby incorporated by reference.

The Commission finds that, in light of the consent between the parties involved, the application is in the public interest and should be granted. It is the expectation of the Commission that the two carriers involved in the boundary change shall collaborate in good faith to ensure that the transition of the customer's service from one carrier to the other shall be as seamless as possible.

# ORDER

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that Application No. C-4521 be, and it is hereby, granted.

IT IS FURTHER ORDERED that the boundaries as shown in Appendix "A" to this Order be, and are hereby made, the official boundaries of Windstream Communications, Inc., and Hamilton Telecommunications.
