On October 9, 2012, Dex One Corporation filed a Petition seeking a Declaratory Ruling that Neb. Admin. Code, Title 291, Chapter 5, § 002.22A is satisfied by delivery of a directory only to access line customers who affirmatively request one. Notice of this Petition appeared in the Daily Record, Omaha, Nebraska, on October 12, 2012. A Petition of Formal Intervention was timely filed by United Telephone Company of the West d/b/a CenturyLink on November 12, 2012.

A planning conference in this matter was held on November 20, 2012 in the Niobrara Conference Room, Lincoln, Nebraska and via teleconference. Ms. Katherine Vogel of Brooks, Pansing Brooks PC LLO, appeared in person on behalf of the Petitioner. Mr. Brooks Harlow appeared for the Petitioner via teleconference. 
