BY THE COMMISSION:

On October 18, 2012, an application was filed by Citizens Telecommunications Company of Nebraska d/b/a Frontier Communications of Nebraska (Frontier), of Rochester, New York, seeking approval of an Amendment to the Interconnection Agreement with AT&T Wireless Services, Inc. (AT&T), of Atlanta, Georgia (collectively, the "Parties"). Notice of the application was published in The Daily Record, Omaha, Nebraska, on October 22, 2012. No protests were filed; therefore, this application is processed pursuant to the Commission's Rule of Modified Procedure.

O P I N I O N A N D F I N D I N G S

Pursuant to Section 252(a) of the Telecommunications Act of 1996 (the Act), the Parties entered into an Interconnection and Traffic Interchange Agreement for Commercial Mobile Radio Services (Agreement) in the State of Nebraska that was approved by the Nebraska Public Service Commission on August 24, 2004.¹

On August 7, 2012, the Parties agreed to an Amendment (Amendment) to the Interconnection Agreement. The Amendment is intended to amend the Agreement by adding the terms, conditions, and rates contained therein. This Amendment, upon approval by the Commission, will become a part of the Agreement.

Interexchange applications are subject to Commission jurisdiction under Neb. Rev. Stat. § 86-129 and Title 291 of the Commission's Rules and Regulations, Chapter 5, Rule 003.12. Upon full consideration of the facts and circumstances, the Commission finds the Parties have provided all the information
